EXOCOAT Ceramic+ Yacht is a high-performance preceramic coating to be used to create durable ceramic layers.

Description and Application

EXOCOAT Ceramic+ Yacht is a high-performance nanotechnology engineered coating for marine applications. Designed to bond strongly to gelcoat, marine paints, and a variety of substrates including aluminum, stainless steel, glass, and plastics (PC, PMMA, ABS), it is ideal for protecting both new and previously coated surfaces.

When applied correctly at dry film thicknesses (DFT) ranging from 1 to 10 μ m, EXOCOAT Ceramic+ Yacht forms a durable, hard, and ultra-slick barrier that helps prolong the life of expensive marine finishes, reducing the frequency and cost of full refits. The coating is very hydrophobic (contact angle >105°), oleophobic, and resistant to UV, saltwater, and temperature variations.

EXOCOAT Ceramic+ Yacht can be sprayed or wiped on, depending on the application requirements and dilution, and provides a self-cleaning effect that dramatically reduces maintenance. Its strong adhesion and crosslinking capabilities create a tough, yet thin ceramic layer that resists abrasion, staining, and marine fouling.

EXOCOAT Ceramic+ Yacht based paints may be wiped or sprayed by conventional or HVLP spray. The coating is preferably ambient cured. Prior to applying the coating, surfaces must be polished using appropriate polishing compounds and polishing machines to ensure optimal adhesion and glossy finishes.
